MINUTES OF THE 10TH MEETING OF THE PROGRAMME STEERING COMMITTEE (PSC) OF ODISHA TRIBAL EMPOWERMNET & LIVELIHOODS PROGRAMME (OTELP) HELD ON 21.11.2012 AT 12.00 NOON IN THE 2ND FLOOR CONFERENCE HALL OF ODISHA SECRETARIAT

- (1) The Meeting was held under the Chairmanship of Sri B.K. Pattnaik, IAS, Chief Secretary and Chief Development Commissioner, Odisha. The list of members participating in the Meeting is annexed at Annexure 'A'.
- (2).At the outset Commissioner-cum-Secretary, ST & SC Development Department welcomed all the members present in the Meeting. He outlined the activities under taken under OTELP; the activities to be taken up under OTELP Plus and briefed the agenda items.
- (3). The Meeting was conducted as per approved agenda. The proceeding of the 9th Meeting of the Programme Steering Committee (PSC) of OTELP held on 30.06.2011 was confirmed since no suggestion or objection had been received from any of the member of the Committee.
- (4). Action taken report on the key recommendations of the last meeting of the PSC was circulated among all the members of the Committee. It was discussed and approved.
- (5). The physical and financial progress of OTELP & OTELP Plus was discussed. Similarly, the project status rating of JRM, 2012 was discussed and the committee noted with satisfaction the one year extension granted by IFAD to the Programme.

- (6). After detailed deliberations on all the points of the Agenda, the following decisions were taken:
- a. It was decided that OTELP Plus will be extended to Bansapal and Harichandanpur blocks of Keonjhar District as per the proposal submitted by Collector & District Magistrate, Keonjhar.
- b. Discussion was held regarding selection of Facilitating NGOs for OTELP Plus area to be operationalized in 139 Micro Watersheds of 8 blocks of Kandhamal, Kalahandi and Rayagada districts. For cluster of 10 MWS or group of it, Facilitating NGO will be contracted to facilitate the community in implementation of the programme by building the capacity and taking up Community mobilization activities. The minutes of the meeting dtd.

 08.11.2012 of the Screening-cum-Selection committee was deliberated and the following NGOs were selected as mentioned here under for the district of Kandhamal and Kalahandi.
